Road Traffic Regulation Act 1985

BRADDAN (OFF STREET) (PARKING PLACES) (AMENDMENT) ORDER 2025

Made:

Coming into operation in accordance with article 2.

Braddan Parish Commissioners, after complying with the requirements of paragraph 1 of Schedule 2 to the Road Traffic Regulation Act 1985, makes the following Order under sections 11 and 13 of that Act.

1 Title

This Order is the Braddan (Off Street) (Parking Places) (Amendment) Order 2025.

2 Commencement

This Order comes into operation on the day after it is made¹.

3 Amendment to the Braddan (Off Street) (Parking Places) Order 2019

- (1) The Braddan (Off Street) (Parking Places) Order 2019² ("the Order") is amended as follows.
- (2) In article 3 (interpretation)
 - (a) after the definition of "emergency services' vehicle", insert
 - **™**"exempted vehicle" means a vehicle to which this Order does not apply under article 10; **™**; and
 - (b) after the definition of "permitted vehicle", insert
 - "reserved parking bay" means a parking bay for use solely by a person who has been issued with a parking permit but only during the days and hours specified in Schedule 1; ■.
- (3) After article 5 (conditions as to the use of a parking place), insert —

Model Additional condition as to use of the Roundhouse Community Complex parking place

- (1) A person may only bring a vehicle into, or cause a vehicle to wait in, the Roundhouse Community Complex parking place for one of the purposes specified in paragraph (2).
- (2) The specified purposes are that at least one of the occupants of the vehicle
 - (a) is using the facilities at the Roundhouse Community Complex; or
 - (b) has business at the Roundhouse Community Complex. 52.
- (4) In schedule 1 (public parking places) to the Order, for the table substitute —



EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Braddan (Off Street) (Parking Places) Order 2019 (SD 2019/0324) ("the Order").

Article 3(2) inserts a definition for exempted vehicle and reserved parking bay into article 3 of the Order.

Article 3(3) inserts a new article 5A relating to an additional condition as to the use of the Roundhouse Community Complex.

Article 3(4) amends the table within schedule 1 of the Order so as to regulate the parking place within the Roundhouse Community Complex, and to introduce a charge for a parking permit for Memorial Hall.

Article 3(5) inserts a map into schedule 2 of the Order.
